- 2. Stop Loss: To minimize the risk of loss, we recommend placing a stop loss at level 655.

Be careful if you fail to stay above the support level or become a support breakdown. (Trading Buy)

### TRADING STRATEGY:

- 1. Target Price: The price has a bullish opportunity to test the resistance level 6,275. If it breaks level 6,275 then the price will go to level 6,350. We recommend to be careful if the price fails to break through or turn around the support area.
- 2. Stop Loss: To minimize the risk of loss, we recommend placing a stop loss at level 5,950.

- 1. Target Price: The price has a bullish opportunity to test the resistance level 560. If it breaks level 560 then the price will go to level 580. We recommend to be careful if the price fails to break through or turn around the support area.
- 2. Stop Loss: To minimize the risk of loss, we recommend placing a stop loss at level 515.
