#### News

- PT Adi Sarana Armada Tbk. (ASSA) has announced a net profit increase of nearly fourfold, reaching Rp152.83 billion in the first half of 2024. This was the result of cost-efficiency measures implemented by the Anteraja subsidiary and the leveraging of synergies with Cargoshare Logistics.
- PT Gajah Tunggal Tbk. (GJTL) has announced that its net revenue, profit before tax, and profit attributable to owners of the parent entity have all increased compared to the same period last year. Additionally, there was an increase in both total liabilities and total assets.
