- PT Sariguna Primatirta Tbk. (CLEO) has announced plans expand to manufacturing capabilities with addition of three new factories in Palu, Pontianak, and Pekanbaru. The company has set aside Rp450 billion for investment, which will be allocated to factory expansion, machinery acquisition, and distribution network expansion.
 - PT Hartadinata Abadi Tbk. (HRTA) has obtained a credit facility of IDR 2.4 trillion from PT Bank Mandiri Tbk. (BMRI). The loan will be used for the repayment of existing credit facilities and to provide additional working capital, thereby enhancing HRTA's financial and operational performance.
