Market Prediction (Session 2)

- PT Siloam International Hospital Tbk. (SILO), an issuer of Lippo Group hospitals, has announced its intention to conduct a voluntary tender offer for 5.85 billion shares. The offer will be made by Sight Investment Company Pte. Ltd. The offering price is Rp2,850 per share, with a total value of IDR 16.6 trillion.
- PT Waskita Karya Tbk. (WSKT) has been removed from the energy ministry's blacklist, enabling the state-owned construction company to resume bidding for energy projects. This decision is consistent with the court's ruling on the postponement of administrative decisions.
