### **Market Prediction (Session 2)**

JCI: The index closed higher and break our resistance flow. JCI is expected to remain volatile in the range 7,193 – 7,246.

- ASII: The price closed at 4,600 (-0.22%) and still buying range. Prices still have the opportunity to strengthen as long as the support level holds. Beware if the price breaks below the support.
- EXCL: The price managed touched first target at 2,230, highest at 2,240 (+2.28%) and closed at 2,170 (-0.91%). Prices still have the opportunity to strengthen as long as the support level holds. Beware if the price breaks below the support.
- JSMR: The price closed at 5,450 (+0.46%) and still positive. Prices still have the opportunity to strengthen as long as the support level holds. Beware if the price breaks below the support.
- PWON: The price closed at first target 448 (+1.82%) and highest at 452 (+2.73). Prices still have the opportunity to strengthen to the next target. Be careful if the price reverses into a bearish candle or weakening.

#### News

- PT Bank Negara Indonesia Tbk. (BBNI) has announced that the BNI Expo 2024 event resulted in total transactions amounting to Rp1.5 trillion, with over 70,000 visitors. The event had a positive impact on MSMEs.
- PT Charlie Hospital Semarang Tbk. (RSCH) has secured a credit facility from Bank Mandiri, comprising IDR 35 billion for investment credit and IDR 5 billion for working capital. The interest rate on the facility is 8.50% per annum, and it is secured by a pledge of land, buildings, trade receivables, and inventories. The facility will be used to complete the construction as well as for the working capital of Charlie Hospital Kendal.
