- PT Astra International Tbk. (ASII), an automotive manufacturer, has announced a decline in car sales for July 2024, with a total of 43,767 units sold. Notwithstanding the decline, Astra's market share remained stable at 57% for the first seven months of the year.
 - PT Dharma Polimetal Tbk. (DRMA), an automotive component issuer owned by TP Rachmat, is seeking to expand its export operations to the United States through a joint venture with Kyungshin Corporation. This strategy is designed to enhance profitability and capitalise on fluctuations in exchange rates. DRMA has already initiated its first export, with plans to expand into other international markets in the future.
