## News

- PT Archi Indonesia Tbk. (ARCI) and PT Ormat Geothermal Indonesia have formed a joint venture, PT Toka Tindu Geothermal, to collaborate on geothermal projects in Indonesia. Archi has a 5% stake in the venture, while Ormat owns the remaining 95%. The objective of this collaboration is to develop geothermal facilities and to produce and sell electricity.
- PT Elnusa Tbk. (ELSA), a subsidiary of Pertamina Hulu Energi, has demonstrated a strong performance in the first half of 2024, with a net profit of Rp 443 billion. The company is targeting an increase in net profit compared to the previous year.
