#### News

The purchase will not have a significant impact on revenue, but it will have an immediate positive effect on profit.

 PT Lautan Luas Tbk. (LTLS) has announced an increase in revenue, cost of revenue, and gross profit for the period ending June 30, 2024. Operating profit and profit before tax also demonstrated substantial growth. In addition, total liabilities and total assets increased during this period.
