News

PT Berdikari Pondasi Perkasa Tbk. (BDKR) has completed a sell-off of 114.14 million shares, with a total value of Rp 105.2 billion, as of August 30, 2024. In the first half of this year, the company recorded a net revenue of Rp 247.69 billion with a net profit of Rp 28.51 billion. In the same period in 2023, its revenue amounted to Rp 278.67 billion with a net profit of Rp 34.39 billion.

 PT Wijaya Karya Tbk. (WIKA) has secured new contracts with a combined value of IDR 11.59 trillion. The Industrial segment generated the most revenue, followed by Infrastructure & Building, Property, and EPCC. This demonstrates WIKA's robust performance in its core business areas, particularly in infrastructure.
