Market Prediction

During last week, JCI closed +0.18% higher to 7,812.13. Foreigners recorded net buy of 17.95 trillion (all market) and net buy of 745.44 billion (RG market). The top 5 foreign net buy stocks were BBRI (804.9B), TLKM (157.7B), BRIS (46.1B), BMRI (36.1B), & BREN (28.4B). Meanwhile, the top 5 net sellers were ADRO (315.8B), ANTM (50.6B), AMMN (27.6B), BBNI (26.6B), BSDE (20.5B).

Major Wall Street indices closed mixed (DJI +0.55%, GSPC +0.13%, IXIC -0.52%). EIDO closed higher by +0.40%. US stocks showed a mixed performance on Monday, with investors being cautious ahead of the Federal Reserve's key policy meeting on Wednesday. Market sentiment focused on an expected rate cut by the Fed, the first since 2020, with the probability of a larger 50 basis point reduction increasing to over 60%, up from 50% last week.

Today's index is expected to move sideways with a chance of strengthening. Today there is a release Balance of Trade data for August period (Prev. \$0.47B vs Fcst. \$1.3B).

Jakarta closed positive with bullish candle. Indicator from stochastic is bearish, MACD histogram is moving positive (line is bullish) and volume is decreasing. Bearish scenario: If it moves bearish again, JCI is expected to weaken again to the support range 7,748 – 7,761. Bullish scenario: If JCI is able to move bullish, JCI has the opportunity strengthen to the resistance range 7,850 – 7,863.

Commodities:

- WTI crude oil futures rose above \$70 per barrel on Monday, extending a 1.4% gain from the previous week, driven by ongoing disruptions to US Gulf oil infrastructure and expectations of a US interest rate cut. Nearly 20% of Gulf of Mexico oil production remains offline due to Hurricane Francine.
- Newcastle coal futures are trading around \$145 per tonne, near the 8-month high of \$150 reached on August 15th, driven by a robust demand outlook. This occurs even as China's energy landscape undergoes a shift.
- Palm Oil increased 92 MYR/MT or 2.47% since the beginning of 2024, according to trading on a contract for difference (CFD) that tracks the benchmark market for this commodity. Historically, Palm Oil reached an all time high of 7268 in March of 2022.

The NY Empire State Manufacturing Index unexpectedly jumped to 11.5 in September 2024, the highest since April 2022, compared to -4.7 in August and forecasts of -3.9. The reading showed business activity in New York state grew for the first time in nearly a year, as new orders climbed (9.4 vs -7.9 in August).

Corporate news

- **PT Adhi Karya Tbk. (ADHI)** successfully pocketed a new contract worth Rp13,6 trillion until August 2024. The acquisition of this new contract is dominated by building projects by 43 percent, water resources by 31 percent, and the rest from roads & bridges, property, manufacturing, and EPC by 26 percent.
- **PT Aneka Tambang Tbk. (ANTM)** has entered into a joint venture with PT Sulsel Citra Indonesia (SCI) and PT Luwu Timur Gemilang (LTG) to develop nickel mining in the Pongkeru Block, East Luwu, South Sulawesi. ANTAM will hold the majority of shares in the joint venture.
- **PT Astra International Tbk. (ASII)** was chosen as one of the 1,000 best companies in the world in the Time World's Best Companies of 2024 list. Only five Indonesian companies are included in this prestigious list, which was announced by TIME Magazine on September 12, 2024.
- **PT Esta Multi Usaha Tbk. (ESTA)** is optimistic about the positive growth of its hospitality segment in the third quarter of 2024, targeting visitors from universities, corporations, and government. To enhance performance, the company is pursuing acquisitions, collaborations with universities, and preparing long-stay guests for corporations. The forthcoming regional head elections will not have a direct impact on the company's operations.
- **PT MNC Digital Entertainment Tbk. (MSIN)** has acquired 9.09% of the shares of PT Tripar Multivision Plus Tbk (RAAM) with the intention of expanding its operations in Indonesia's media and entertainment sector. The acquisition will facilitate collaborations in the creation and distribution of content across all media platforms.
- **PT Tripar Multivision Plus Tbk (RAAM)** has announced a decline in sales, gross profit, and net profit for the 2024 financial year in comparison to the previous year. Additionally, the company encountered an uptick in operating expenses and total liabilities.


