In session 1, JCI closed down -1.35% to the level of 7.592.64.

Market Prediction (Session 2)

JCI: The index closed negative and break our support flow. JCI is expected to remain volatile in the range 7,554 – 7,627.

- Sentra Investasi has reduced its holding in PT. Lavender Bina Cendikia Tbk. (BMBL) by selling 22.60 million shares in several stages, resulting in a realised gain of approximately Rp365.4 million. The company's current holding is 166.27 million shares.
- Yulisar Khiat, Director of PT Medikaloka Hermina Tbk (HEAL), has increased his share ownership through the purchase of 130,000 HEAL shares at a price of IDR 1,405 per share. Following the purchase, shareholding in HEAL increased to 1,929,892,120 shares, representing 12.5595% of the total issued share capital.
