#### **Market Prediction (Session 2)**

JCI: The index closed negative with bearish candle. JCI is expected to remain volatile and maintain its negative movement.

- AKRA: The price closed at 1,595 (+0.95%) and still positive. Prices still have the opportunity to strengthen as long as the support level holds. Beware if the price breaks below the support.
- ANTM: The price managed touched our second target at 1,590 (+3.58%) and closed at 1,575 (+2.61%). Prices still have the opportunity to strengthen to the next target. Be careful if the price reverses into a bearish candle or weakening.
- KRAS: The price break our second target at 138, highest at 158 (+18.80%) and closed at 155 (+16.54%). Prices still have the opportunity to strengthen to 159. Beware if the price breaks below new support at 151.
- RAJA: The price break our second target at 1,400, highest at 1,475 (+9.26%) and closed at 1,450 (+7.41%). Prices still have the opportunity to strengthen to 1,500. Beware if the price breaks below new support at 1,415.

#### News

 PT. Harum Energy Tbk. (HRUM) has completed a loan transaction with a value of IDR 1.43 trillion (USD 95 million), involving four entities of the company. The purpose of the loan is to provide support for capital expenditure, working capital, general corporate financing, and investment for the entities.

 PT. Samuel Tumbuh Bersama has sold its shares in PT. Nusantara Sawit Sejahtera Tbk. (NSSS) on 24 September 2024, reducing its shareholding to 26.95%. NSSS shares were up 1% in today's trading.
