Be careful if you fail to stay above the support level or become a support breakdown. **(Trading Buy)** 

### TRADING STRATEGY:

1. Target Price: The price has a bullish opportunity to test the resistance level 2,410. If it breaks level 2,410 then the price will go to level 2,450. We recommend to be careful if the price fails to break through or turn around the support area.

2. Stop Loss: To minimize the risk of loss, we recommend placing a stop loss at level 2,300.

1. Target Price: The price has a bullish opportunity to test the resistance level 1,055. If it breaks level 1,055 then the price will go to level 1,075. We recommend to be careful if the price fails to break through or turn around the support area.

2. Stop Loss: To minimize the risk of loss, we recommend placing a stop loss at level 1,005.
