Market Review (Session 1)

In session 1, JCI closed up +0.05% to the level of 7,500.13.

Market Prediction (Session 2)

JCI: The index closed positive and inline our projection. JCI is expected to have the opportunity to strengthen from the closing level of session 1.

- AUTO: The price managed touched our first target at 2,410, highest at 2,420 (+2.54%) and closed at 2,370 (+0.42%). Prices still have the opportunity to strengthen as long as the support level holds. Beware if the price breaks below the support.
- LSIP: The price closed at our second target 1,075 (+3.86%) and highest at 1,080 (+4.35%). Prices still have the opportunity to strengthen as long as the support level holds. Beware if the price breaks below the support. The new support benchmark is at 1,055.
- PGAS: The price managed touched our first target at 1,530 and highest at 1,535 (+2.33%) and closed at 1,510 (+0.67%). Prices still have the opportunity to strengthen as long as the support level holds. Beware if the price breaks below the support.
- SILO: The price closed at 2,960 (-3.90%) and breakdown support. Prices still have the opportunity to strengthen if price back to above support level. Beware if the price breaks below next support at 2,900.

News
