News

- PT. Pyridam Farma Tbk. (PYFA) and the Research Genetic Cancer Center (RGCC) have formed a strategic partnership to fight cancer and improve access to quality treatment. PYFA will assume responsibility for marketing and distribution of RGCC products in Indonesia, while RGCC will provide support for PYFA's entry into the European market.
- The Indonesia Stock Exchange (IDX) has removed PT. Trimuda Nuansa Citra Tbk. (TNCA) from special monitoring and resumed trading. TNCA plans to implement corporate actions and hold an extraordinary general meeting to change the board of directors and commissioners.
