In session 1, JCI closed down -1.10% to the level of 7,610.19.

#### Market Prediction (Session 2)

JCI: The index closed lower and break our support flow. JCI is expected to remain volatile in the range 7,581 - 7,635.

- AUTO: The price managed touched our first target at 2,560, highest at 2,570 (+2.39%) and closed at 2,530 (+0.80%). Prices still have the opportunity to strengthen as long as the support level holds. Beware if the price breaks below the support.
- BMRI: The price closed at 6,825 (-3.19%) and breakdown support. Prices still have the opportunity to strengthen if price back to above support level. Beware if the price breaks below new support at 6,700.
- BSBK: The price managed touched our first target at 64, highest at 65 (+4.84%) and closed at 60 (-3.23%). Prices still have the opportunity to strengthen as long as the support level holds. Beware if the price breaks below the support.
- SMGR: The price closed at 4,230 (-3.64%) and breakdown support. Prices still have the opportunity to strengthen if price back to above support level. Beware if the price breaks below new support at 4,130.

#### News

- PT. Adaro Energy Indonesia Tbk. (ADRO) will hold Extraordinary General Meeting Shareholders (EGMS) to seek approval for changing its name and distributing cash dividends. The meeting will be held both electronically and physically on November 18, 2024.
- PT. Sri Rejeki Isman Tbk. (SRIL) is at risk of being removed from the Indonesia Stock Exchange (IDX) due to its bankruptcy declaration. The stock has been suspended for 42 months, meeting the criteria for delisting. SRIL's management is required to provide information regarding the bankruptcy verdict.
