In session 1, JCI closed down -0.21% to the level of 7,618.25.

Market Prediction (Session 2)

JCI: The index closed negative with bearish candle. JCI is expected to have the opportunity to strengthen from the closing level of session 1.

- ADMR: The price closed at 1,450 (-0.68%) and still buying range. Prices still have the opportunity to strengthen as long as the support level holds. Beware if the price breaks below the support.
- ERAL: The price managed touched our first target at 288, highest at 290 (+2.84%) and closed at 282 (0%). Prices still have the opportunity to strengthen as long as the support level holds. Beware if the price breaks below the support.
- INKP: The price closed at 8,200 (+0.31%) and still positive. Prices still have the opportunity to strengthen as long as the support level holds. Beware if the price breaks below the support.
- PTPP: The price managed touched our second target at 460, highest at 464 (+4.50%) and closed at 458 (+3.15%). Prices still have the opportunity to strengthen to the next target. Be careful if the price reverses into a bearish candle or weakening.

News

- PT. Bank Syariah Indonesia Tbk. (BRIS) has announced a net profit of IDR 5.1 trillion for the third quarter of 2020, representing a 21.6% increase compared to the same period last year. The bank's revenue, net operating margin, fee-based income, and other income have all grown.
- PT. Garuda Indonesia (Persero) Tbk. (GIAA) has once again averted bankruptcy, as the Supreme Court has rejected a review request by Greylag 1446. The court's decision is final, and there are no further legal avenues for appeal.
