### 6,250 – 6,150 (Support), 6,405 – 6,620 (Resistance)



**Jakarta Composite Index.** Yesterday's JCI intraday high was precisely held back by the upper resistance line of the short-term downtrend channel, making 6,405 the current critical resistance level. A successful breakout above this level could open the path toward the next targets at 6,620 – 6,700, or even as high as 7,000 (provided JCI does not fall back below the key support level at 6,150).

**ADVICE:** Execute average up strategies gradually and with discipline, while paying close attention to the resistance levels of each individual portfolio holding.
